**Toll Revenue for Q3FY16**

**Toll revenue received from the below 8 operational SPVs have increased from Rs. 1,466.1 mn in Q3FY15 to Rs. 1,813.4 mn in Q3FY16.**

**ARRIL** - Toll revenue received in Q3FY16 has increased by approx 3.6% to Rs. 231.1 mn from Rs. 223.0 mn in Q3FY15.

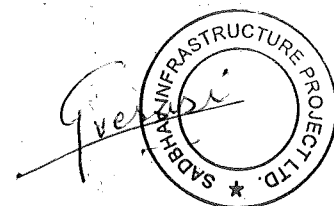
**AJTL** - Toll revenue received for LCV and MAV category in Q3FY16 has increased by approx 20.2% to Rs. 62.9 mn from Rs. 52.3 mn in Q3FY15. In addition to the LCV and MAV category, Trucks category contributed toll revenue of Rs. 17.5 mn in Q3FY16.

**BHTPL** - Toll revenue received in Q3FY16 has increased by approx 9.9% to Rs. 279.8 mn from Rs. 254.6 mn in Q3FY15.

**HYTPL** - Toll revenue received in Q3FY16 has increased by approx 25.9% to Rs. 141.9 mn from Rs. 112.7 mn in Q3FY15.

**MBCPNL** - Toll revenue received in Q3FY16 has increased by approx 74.8% to Rs. 415.5 mn from Rs. 237.7 mn in Q3FY15. During Q3FY15, 9 Check Posts were generating revenue while during Q3FY16 13 Check Posts were generating revenue.

**DPTL** - Toll revenue received in Q3FY16 has increased by approx 14.7% to Rs. 384.4 mn from Rs. 335.1 mn in Q3FY15.



**RPTPL** – Toll revenue received in Q3FY16 has increased by approx. 4.4% to Rs. 219.5 mn as against Rs. 210.2 mn in Q3FY15.


**SUTPL** – Toll revenue received in Q3FY16 stood at Rs. 60.8 mn. Toll collection started from 6<sup>th</sup> December, 2015.
