**Toll Revenue for Q4FY16**

**Toll revenue received from the below 8 operational SPVs have increased from Rs. 1,552.4 mn in Q4FY15 to Rs. 2,020.9 mn in Q4FY16.**

**ARRIL** - Toll revenue received in Q4FY16 has increased by approx 10.5% to Rs. 246.2 mn from Rs. 222.7 mn in Q4FY15.

**AJTL** - Toll revenue received for LCV and MAV category in Q4FY16 has increased by approx 22.1% to Rs. 69.4 mn from Rs. 56.8 mn in Q4FY15. In addition to the LCV and MAV category, Trucks category contributed toll revenue of Rs. 18.3 mn in Q4FY16.

**BHTPL** - Toll revenue received in Q4FY16 has increased by approx 10.3% to Rs. 302.2 mn from Rs. 273.9 mn in Q4FY15.

**HYTPL** - Toll revenue received in Q4FY16 has increased by approx 29.6% to Rs. 153.2 mn from Rs. 118.1 mn in Q4FY15.

**MBCPNL** - Toll revenue received in Q4FY16 has increased by approx 65.6% to Rs. 431.5 mn from Rs. 260.6 mn in Q4FY15. During Q4FY15, 9 Check Posts were generating revenue while during Q4FY16 13 Check Posts were generating revenue.

**DPTL** - Toll revenue received in Q4FY16 has increased by approx 9.8% to Rs. 391.1 mn from Rs. 356.2 mn in Q4FY15.

**RPTPL** - Toll revenue received in Q4FY16 has reduced by approx. 19.5% to Rs. 180.9 mn as against Rs. 224.8 mn in Q4FY15. Toll collection was impacted from 17<sup>th</sup> February, 2016 to 27<sup>th</sup> February, 2016 due to agitation/violence in the state of Haryana.

**SUTPL** - Toll revenue received in Q4FY16 stood at Rs. 228.18 mn. Toll collection started from 6<sup>th</sup> December, 2015.
