**Toll Revenue for Q1FY19**

**Toll revenue received from the below 10 operational SPVs (apart from NSEL which is an annuity project) have increased by approx 13.9% to Rs. 2,749.9 mn in Q1FY19 from Rs. 2,414.2 mn in Q1FY18.**

**ARRIL** – Toll revenue received (excluding car) in Q1FY19 has increased by approx 9.2% to Rs. 238.8 mn from Rs. 218.7 mn in Q1FY18.

**AJTL** - Toll revenue (excluding cars and state buses) received in Q1FY19 has increased by approx 10.2% to Rs. 101.9 mn from Rs. 92.5 mn in Q1FY18.

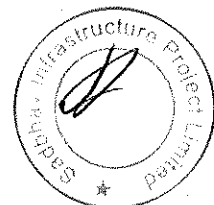
**BHTPL** - Toll revenue received in Q1FY19 has increased by approx 6.8% to Rs. 315.9 mn from Rs. 295.9 mn in Q1FY18.

**HYTPL** - Toll revenue received in Q1FY19 has increased by approx 17.9% to Rs. 201.8 mn from Rs. 171.1 mn in Q1FY18.

**MBCPNL** - Toll revenue received in Q1FY19 has increased by approx 29.1% to Rs. 582.4 mn from Rs. 451.1 mn in Q1FY18. During Q1FY19, 18 Check Posts were generating revenue while during Q1FY18 16 Check Posts were generating revenue.

**DPTL** - Toll revenue received in Q1FY19 has increased by approx 7.4% to Rs. 457.9 mn from Rs. 426.4 mn in Q1FY18.

**RPTPL** – Toll revenue received in Q1FY19 has increased by approx 22.4% to Rs. 302.5 mn as against Rs. 247.1 mn in Q1FY18.

**BRTPL** - Toll revenue received in Q1FY19 has reduced by approx 0.9% to Rs. 115.2 mn as against Rs. 116.2 mn in Q1FY18.

**RHTPL** - Toll revenue received in Q1FY19 has increased by approx 14.1% to Rs. 151.1 mn as against Rs. 132.4 mn in Q1FY18.
