## Toll Revenue for Q2FY17

Toll revenue received from the below 10 operational SPVs have increased from Rs. 1,615.0 mn in Q2FY16 to Rs. 2,144.0 mn in Q2FY17.

**ARRIL** – Toll revenue received in Q2FY17 has increased by approx 6.8% to Rs. 227.0 mn from Rs. 212.5 mn in Q2FY16.

**AJTL** - Toll revenue received in Q2FY17 has increased by approx 28.8% to Rs. 88.3 mn from Rs. 68.5 mn in Q2FY16.

**BHTPL** - Toll revenue received in Q2FY17 has increased by approx 1.4% to Rs. 285.6 mn from Rs. 281.6 mn in Q2FY16.

**HYTPL** - Toll revenue received in Q2FY17 has increased by approx 5.4% to Rs. 125.1 mn from Rs. 118.7 mn in Q2FY16.

MBCPNL - Toll revenue received in Q2FY17 has increased by approx 10.8% to Rs. 406.3 mn from Rs. 366.9 mn in Q2FY16. During Q2FY17, 13 Check Posts were generating revenue while during Q2FY16 9 Check Posts were generating revenue till 4th August, 2015 while 13 Check Posts were generating revenue from 5th August, 2015.

**DPTL** - Toll revenue received in Q2FY17 has increased by approx 8.4% to Rs. 398.5 mn from Rs. 367.7 mn in Q2FY16.

RPTPL – Toll revenue received in Q2FY17 has reduced by approx 3.0% to Rs. 193.3 mn as against Rs. 199.2 mn in Q2FY16.

**BRTPL** - Toll revenue received in Q2FY17 stood at Rs. 93.7 mn. Toll collection started from 9th June, 2016.

RHTPL - Toll revenue received in Q2FY17 stood at Rs. 82.8 mn. Toll collection started from 3<sup>rd</sup> August, 2016.
