**Toll Revenue for Q4FY18**

**Toll revenue received from the below 10 operational SPVs (apart from NSEL which is an annuity project) have increased by approx 10.7% to Rs. 2,620.0 mn in Q4FY18 from Rs. 2,367.2 mn in Q4FY17.**

**ARRIL** – Toll revenue received (excluding car) in Q4FY18 has increased by approx 9.4% to Rs. 245.3 mn from Rs. 224.1 mn in Q4FY17.

**AJTL** - Toll revenue (excluding cars and state buses) received in Q4FY18 has reduced by approx 12.5% to Rs. 102.2 mn from Rs. 90.9 mn in Q4FY17.

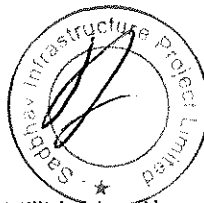
**BHTPL** - Toll revenue received in Q4FY18 has increased by approx 8.9% to Rs. 318.9 mn from Rs. 292.8 mn in Q4FY17.

**HYTPL** - Toll revenue received in Q4FY18 has increased by approx 17.1% to Rs. 179.3 mn from Rs. 153.1 mn in Q4FY17.

**MBCPNL** - Toll revenue received in Q4FY18 has increased by approx 10.1% to Rs. 493.5 mn from Rs. 448.3 mn in Q4FY17. During Q4FY18, 18 Check Posts were generating revenue while during Q4FY17 16 Check Posts were generating revenue.

**DPTL** - Toll revenue received in Q4FY18 has increased by approx 5.7% to Rs. 474.7 mn from Rs. 449.1 mn in Q4FY17.

**RPTPL** – Toll revenue received in Q4FY18 has increased by approx 29.1% to Rs. 290.0 mn as against Rs. 224.7 mn in Q4FY17.

**SUTPL** - Toll revenue received in Q4FY18 has increased by approx 4.8% to Rs. 261.7 mn as against Rs. 249.7 mn in Q4FY17.

**BRTPL** - Toll revenue received in Q4FY18 has reduced by approx 0.5% to Rs. 104.0 mn as against Rs. 104.6 mn in Q4FY17.

**RHTPL** - Toll revenue received in Q4FY18 has increased by approx 15.6% to Rs. 150.3 mn as against Rs. 130.0 mn in Q4FY17.


