Report on audit of the Financial Statements

Opinion

We have audited the accompanying financial statements of Sadbhav Vidarbha Highway Private Limited (Formerly known as Sadbhav Vidarbha Highway Private Limited) ("the Company"), which comprise the Balance Sheet as at 31st March, 2022, the Statement of Profit and Loss (including Other Comprehensive Income), the Statement of Cash Flow and Statement of Changes in Equity for the year then ended, and a summary of the significant accounting policies and other explanatory information (herein after referred to as 'financial statements').

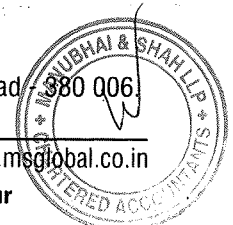

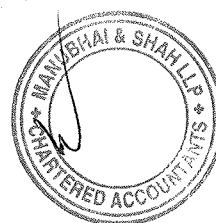
Management's Responsibility for the Financial Statements

As part of an audit in accordance with SAs, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

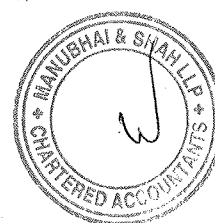

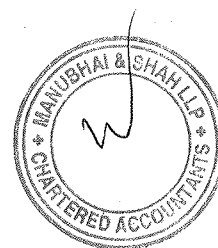

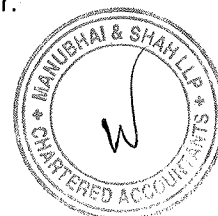
Management's Responsibility for Internal Financial Controls
