1. Approved and adopted the standalone and consolidated Unaudited Financial Results of the Company for the Quarter and nine months ended on 31st December, 2024.

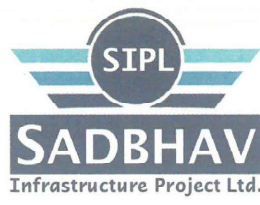
Pursuant to Regulation 33 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we hereby enclose the following:
