**Toll Revenue for Q1FY17**

Toll revenue received from the below 9 operational SPVs have increased from Rs. 1,644.3 mn in Q1FY16 to Rs. 2,101.2 mn in Q1FY17.

**ARRIL** - Toll revenue received in Q1FY17 has increased by approx 6.4% to Rs. 236.7 mn from Rs. 222.2 mn in Q1FY16.

**AJTL** - Toll revenue received for LCV and MAV category in Q1FY17 has increased by approx 35.4% to Rs. 77.8 mn from Rs. 57.5 mn in Q1FY16. In addition to the LCV and MAV category, Trucks category contributed toll revenue of Rs. 21.8 mn in Q1FY17.

**BHTPL** - Toll revenue received in Q1FY17 has increased by approx 7.2% to Rs. 303.9 mn from Rs. 284.2 mn in Q1FY16.

**HYTPL** - Toll revenue received in Q1FY17 has increased by approx 9.7% to Rs. 148.7 mn from Rs. 133.5 mn in Q1FY16.

**MBCPNL** - Toll revenue received in Q1FY17 has increased by approx 23.8% to Rs. 415.3 mn from Rs. 335.4 mn in Q1FY16. During Q1FY17, 13 Check Posts were generating revenue while during Q1FY16 9 Check Posts were generating revenue.

**DPTL** - Toll revenue received in Q1FY17 has increased by approx 16.5% to Rs. 417.5 mn from Rs. 358.4 mn in Q1FY16.

**RPTPL** - Toll revenue received in Q1FY17 has reduced by approx 6.4% to Rs. 204.6 mn as against Rs. 218.6 mn in Q1FY16.

**SUTPL** - Toll revenue received in Q1FY17 stood at Rs. 252.0 mn. Toll collection started from 6<sup>th</sup> December, 2015.



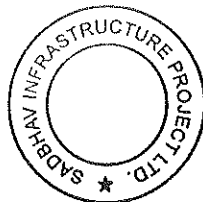
