### **Toll Revenue for Q2FY19**

**Toll revenue received from the below 10 operational SPVs (apart from NSEL which is an annuity project) have increased by approx 12.5% to Rs. 2,685.5 mn in Q2FY19 from Rs. 2,386.3 mn in Q2FY18.**

**ARRIL** - Toll revenue received (excluding car) in Q2FY19 has increased by approx 10.0% to Rs. 232.2 mn from Rs. 211.2 mn in Q2FY18.

**AJTL** - Toll revenue (excluding cars and state buses) received in Q2FY19 has increased by approx 10.0% to Rs. 94.8 mn from Rs. 86.2 mn in Q2FY18.

**BHTPL** - Toll revenue received in Q2FY19 has increased by approx 6.3% to Rs. 315.3 mn from Rs. 296.7 mn in Q2FY18.

**HYTPL** - Toll revenue received in Q2FY19 has increased by approx 7.7% to Rs. 170.7 mn from Rs. 158.5 mn in Q2FY18.

**MBCPNL** - Toll revenue received in Q2FY19 has increased by approx 32.8% to Rs. 573.9 mn from Rs. 432.2 mn in Q2FY18. During Q2FY19, 18 Check Posts were generating revenue while during Q2FY18 16 Check Posts were generating revenue.

**DPTL** - Toll revenue received in Q2FY19 has increased by approx 9.7% to Rs. 483.6 mn from Rs. 440.8 mn in Q2FY18.

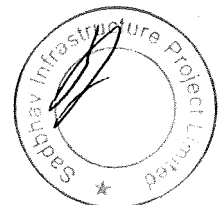
**RPTPL** - Toll revenue received in Q2FY19 has increased by approx 5.7% to Rs. 264.3 mn as against Rs. 250.1 mn in Q2FY18.

**SUTPL** - Toll revenue received in Q2FY19 has increased by approx 5.9% to Rs. 280.4 mn as against Rs. 264.7 mn in Q2FY18.


